APPENDIX. NETWORK STAFFING AND STRUCTURE

The management staff of Network 8 consists of:

- **Executive Director:** Jerry Fuller, MSW, LCSW, has been a member of the Network staff since 1988. He administers the contract, supervises key staff and serves as primary liaison to the Network 8 board of directors.
- **Patient Services Director:** NaTasha Avery, DRPH, LMSW, CHES, is the team lead for patient and family engagement contract goals, including maintenance of the patient-focused learning and action network. Other tasks include management of the patient grievance process, production of an updated social marketing plan, and development of patient and provider educational resources.
- **Quality Improvement Director:** Sheila McMaster, MSN, CNN, CPHQ, coordinates the work of the Quality Improvement Nurse, the Quality Improvement Analyst and the Quality Improvement Specialist. She serves as the clinical lead and specialist on all QI activities and educational campaigns, and she serves as AIM 3 lead for quality incentive program tasks. She is staff liaison to the Medical Review Board and manages the Network's internal quality control plan.
- **Data Manager:** Robert Bain, MM, MCM, a CompTIA Project+ Certified Professional, supervises two data specialists responsible for the accuracy, completeness and timeliness of data submission and user support of the CROWNWeb information system. The DM provides IS support for Network staff and serves as the System Security Officer for the organization. He maintains Network 8's risk assessment, system security plan and business continuity plan and provides IS support to the staff during emergencies.

Additional staff of Network 8 consists of:

- **Community Engagement Coordinator:** Brenda Dyson coordinates the recruitment and implementation of the patient and family engagement LAN and the Patient Advisory Committee. She works with the patient groups to plan educational outreach for patients, and she coordinates the annual professional education conference. She serves as emergency response co-leader and provides front-line consultation to facility staff callers.
- **Quality Improvement Nurse:** Pam Stephens, RN, serves as clinical lead for the HAI team and oversees direct communications with facility counterparts.
- **Quality Improvement Analyst:** Kristi Durham, RHIA, oversees quality activities associated with HAI, and she serves as front-line support for incoming patient grievances.
- **Quality Improvement Specialist:** Casey Magee provides graphics and communications support, serves as webmaster, serves as emergency response team co-leader, and provides back-up support for incoming patient calls.
- **Provider Data Support Specialist:** Janet Henn is the senior data specialist and primary facility contact for CROWNWeb data matters, including reconciliation of patients by



- facility, trouble-shooting errors related to discharges and admissions, and mentoring facility staff in the logical workflow of the CROWNWeb information system.
- **Data Monitoring and Review Specialist:** Shirley Smith manages transplant facility data operations, updates the provider certifications provided by CMS, and works with facilities to improve reporting completeness.
 - **Office Manager:** Mary Jane Dearman provides administrative support to the executive director, provides office management, oversees visitor security, records accounts payables, and serves as liaison to the Alliant human relations department.

Overall, the Network employed 10 full-time staff and one part-time staff in 2014. There were no significant changes internally or in the corporate structure of the organization.

NETWORK BOARDS AND COMMITTEES

Board of Directors

The Network 8 Board of Directors (BOD) is composed of 11 voting members, three ex officio members: the MRB chairman, the Network Council Chair, and the Alliant President and CEO. The function of the BOD includes setting policy, managing Network 8's financial operations and directing administrative staff in performance of contract requirements. The BOD convenes four times yearly, twice in person and twice by teleconference. The board develops and/or approves policies and procedures, administers affairs of the Network Council (an advisory body representing all regional ESRD providers) and approves appointments to the Medical Review Board.

In addition to routine program and financial oversight, the Compliance and Audit Committee of the Board reviewed alternative membership categories to comply with new CMS governance guidelines, and the Board accepted their recommendations. The Board will include two patients, representatives of other healthcare settings, and representatives not associated with a healthcare entity. A maximum of two members may be affiliated with any one dialysis corporation, and no single profession may be represented by a majority of members on the Board.

Medical Review Board

The Medical Review Board (MRB) is a multidisciplinary committee similar in composition to the BOD. Among its principal objectives are developing and implementing quality improvement and patient safety initiatives. The Patient Grievance Committee is charged with evaluating patient grievances meeting specific criteria, as well as complaints involving physicians. The MRB oversees Network 8’s quality initiatives with guidance from the CMS and regional offices. On-site investigations occasionally are undertaken by the MRB as circumstances warrant. Key successes of the MRB included oversight of QI projects and educational campaigns, all of which exceeded CMS performance goals.

Network Council (NWC)

The Network Council (NWC) is a representative organization consisting of one professional representative appointed by each dialysis and transplant facility and the patient members of the BOD and MRB.

Council members have a variety of ways to interact with Network 8, including direct contact with staff, contact with their three elected officers and contact with BOD and MRB members. Additionally, the council chair, who is elected by membership, provides policy-making input to the BOD as an ex-officio member of that body.

Council members contribute ideas that help shape the Network’s provider education strategy, referred to in the statement of work as the marketing plan. Members are regularly contacted and encouraged to supply nominees to the MRB and to the BOD, and they may nominate themselves to serve as vacancies occur.



Council officers are chair, vice-chair, and secretary. Lorrie Haggard assumed chairmanship in 2014 when Karen Bush resigned. Officers meet throughout the year in person or by telephone to conduct business and to plan for the annual meeting.
